Director General of Foreign Trade (DGFT), Ministry of Commerce & Industry, New Delhi has notified permitting export of cotton (including cotton waste) under Open General Licence (OGL), with effect from 01-10-2010, vide a Notification No. 58/2009-14 dated 17-08-2010.

Registration of contract/s with Office of the Textile Commissioner for export of cotton prior to shipment will however be mandatory.

(E) In exercise of the powers conferred by Section 5 of the Foreign Trade (Development & Regulation) Act, 1992 (No.22 of 1992) read with Para 1.3 and 2.1 of the Foreign Trade Policy, 2009-14, and also read with Notification No. 26 (RE 2008)/2004-09 dated 22.7.2008 and Notification No. 44/2009-14 dated 21.05.2010, the Central Government hereby makes the following amendments in the Schedule 2, Table B of ITC HS Classifications of Export and Import Items as under:-

2. With immediate effect, existing entries against S. No. 161 A of the table at the end of Para 2 of Notification No. 44 /2009-14 dated 21.05.2010 shall be substituted as follows:
